MINUTES of the Regular Board Meeting of the Northbrook Park District Board of Commissioners held Wednesday, April 25, 2018 in the Administration Building located at 545 Academy Drive, Northbrook, Illinois.

CALL TO ORDER AND ROLL CALL—REGULAR BOARD MEETING

President Randel called the Regular Board Meeting to order at 7:00pm. On a roll call by the Assistant Secretary, the following members were in attendance:

APPROVAL OF AGENDA

President Randel called for any changes to the Agenda. A motion was made to amend the Agenda, adding 10.c. Committee Reports and removing 7.d. Approval of Professional Service Contract with Wight & Company, Inc. The motion was seconded and unanimously approved on a voice vote.

Minutes of the Regular Board Meeting of March 28, 2018 were previously distributed and reviewed. President Randel called for any changes to the Minutes. Commissioner Slepicka reported on the most recent Village of Northbrook Economic Development Committee meeting. The 6B request for Pyramid Packaging, Inc. is moving toward acceptance. *Active Killer: Train the Trainer* sessions are continuing. Sales tax in Northbrook went up 0.25% due to the drop in sales of goods. At Northbrook Court, Macy's sold their retail space to GGP, the owner of the shopping center.

EXECUTIVE DIRECTOR REPORT

- 1) Marketing plans are underway for camps, golf and aquatics. The new Summer Guide will be available next week.
- 2) Attended Seasonal Staff Golf Kickoff meeting on April 10. Leagues will start next week.
- 3) We are working out the details of a reciprocity agreement with Sunset Valley as they are under construction this summer.
- 4) Friends of Chicago River will hold their 26th Annual Chicago River Day. Glenbrook North High School suggested cleanup for the section of river flowing through Techny Prairie Parks and Fields. On May 12, litter will be picked-up and District Parks staff will dispose of the items.
- 5) At the Northbrook Theatre, *Wizard of Oz* tickets go on sale May 1 to the public. *Madagascar* sold almost 1,500 tickets to the six shows comprised of three casts, which equates to 93% theatre capacity.
- 6) Second round interviews are taking place for the Recreation Supervisor position overseeing Active Adults and Seniors.
- 7) NSSRA Shining Stars Banquet was held on Friday, April 20. Thank you President Randel, Vice President Chambers and Commissioners Chalem and Schyman for attending on the District's behalf.
- 8) Thank you to Vice President Chambers for attending the IAPD Legislative Conference in Springfield.
- 9) To prepare for our partnership with NSSRA, last week a team of seven staff visited two park districts, Downers Grove and Addison. These two districts have previously partnered with an SRA.

- 1) Teams Elite program had an amazing turnout of almost 100 skaters for tryouts for the 2018-2019 season. The success from our previous year brought in more skaters. It is possible, at some point, our Junior team could qualify for a Team USA competition.
