MINUTES of the Regular Board Meeting of the Northbrook Park District Board of Commissioners held Wednesday, July 25, 2018 in the Administration Building located at 545 Academy Drive, Northbrook, Illinois.

CALL TO ORDER AND ROLL CALL—REGULAR BOARD MEETING

President Randel called the Regular Board Meeting to order at 7:00pm. On a roll call by Generalist Gambino, the following members were in attendance:

RECOGNITION OF VISITORS - Todd Marver, The Northbook Tower; Karen Teitelbaum, Resident

Karen Teitelbaum addressed the Board of Commissioners and expressed concern on the limited shade area and number of lanes for swimming. She asked the Board if it is possible to consider installing another big canopy to provide another shaded area to lounge and to consider having 1 or 2 more lanes for swimming.

APPROVAL OF AGENDA

President Randel called for any changes to the Agenda. A motion was made to amend the Agenda, adding the word "culvert" to 6b. Rejection of Wood Oaks Green Park Replacement so it reads 6b. Rejection of Wood Oaks Green Park Culvert Replacement. The motion was seconded and unanimously approved on a voice vote.

APPROVAL OF MINUTES

Minutes of the Regular Board Meeting of June 27, 2018 were previously distributed and reviewed. President Randel called for any changes to the Minutes. A change was made to the Minutes of the Regular Board Meeting. The *Return to Open Session* section was changed to read as "After discussing matters of Setting a Price for Sale or Lease of Property, the Board arose from Closed Session at 8:02pm and reconvened to the Regular Board Meeting." A motion was made to approve the Minutes of the Regular Board Meeting of June 27, 2018.

The Minutes of the Closed Session Meeting of June 27, 2018 were previously distributed and reviewed. President Randel called for any changes to the Minutes. Hearing none, Commissioner Simon made a motion to approve the Minutes of the Closed Session Meeting of June 27, 2018. The motion was seconded and approved on a voice vote with 6 ayes and President Randel abstained.

<u>BOARD COMMITTEE REPORTS</u> – Commissioner Slepicka briefly shared what was discussed at the Economic Development Committee Meeting, which included feedback from community members concerned about economic development. They seemed to think the Village was more interested in businesses than residents. The Village thought an education plan would be worthwhile and hopes to use taxing authorities to convey the message that it supports both residents and businesses. Commissioner Slepicka also mentioned what the probable use will be for the building on Lake Cook Road and Sanders.
