MINUTES of the Regular Board Meeting of the Northbrook Park District Board of Commissioners held Wednesday, August 22, 2018 in the Administration Building located at 545 Academy Drive, Northbrook, Illinois.

CALL TO ORDER AND ROLL CALL—REGULAR BOARD MEETING

Vice President Chambers called the Regular Board Meeting to order at 7:00pm. On a roll call by Assistant Secretary Peterson, the following members were in attendance:

Valerie Brostrom addressed the Board of Commissioners to introduce herself and Josh Ryan as members of the Northbrook Cycle Committee. Ms. Brostrom is the Race Director and Mr. Ryan is the President. Ms. Brostrom highlighted events and welcomed Board members to join the group at the Velodrome. The Northbrook Cycle organization holds meetings in the winter and is trying to reach out to community residents.
