Staff Recommendation:

Staff recommends the approval of the District Painting base bid in the amount of \$29,100 from Katco, Inc. of Munster, IN.

Background & Analysis:

This project includes the painting of the ball field fencing at Indian Ridge, Wescott and Greenfield Parks, the parking lot light poles at the Leisure Center, and the slide tower at Meadowhill Aquatic Center.

The lowest bidder was disqualified because of lack of experience painting metal fences, structures and exterior light poles. The lowest most qualified bidder was Katco, Inc.
