MINUTES of the Administration and Finance Committee Meeting of the Northbrook Park District Board of Commissioners held Monday, September 17, 2018 in the Joe Doud Administration Building located at 545 Academy Drive, Northbrook, Illinois.

APPROVAL OF MEETING MINUTES

Minutes of the Administration & Finance Committee Meeting of August 16, 2018 were approved as presented.

INFORMATIONAL ITEMS/VERBAL UPDATE -

Manager Report, Sports Center Review

Manager Shields gave a presentation on the Sports Center covering fiscal years 2014-2018. Topics included overall operations, capacity, programming and rentals, recent projects and the upcoming year. The Committee asked Manager Shields questions about the presentation.

Manager Report, Sports Center Building Assessment

Project Manager Buch and Specialist Scharp gave a presentation on the full building assessment of the Sports Center. The Sports Center building was built in 1968 and underwent a \$7.6 million renovation in 1999-2000. Due to the age and condition of the building a comprehensive building analysis was completed by FMG Architects. The HVAC system, roof condition, exterior skin/metal panels, ice/mechanical making equipment and electrical system were evaluated and areas of maintenance were suggested. A mechanical system review was conducted to determine if the system is at capacity or has potential to support additional ice if future expansion were to be considered. Further discussions regarding the Sports Center Building will take place during the November CIP meeting. The Committee asked Project Manager Buch and Specialist Scharp questions about the presentation.

Director Munn noted that Eric Anderson of Piper Jaffray will present at the October 18 Administration and Finance Committee meeting.

The Committee recommended the Board approve the August 2018 vouchers in the amount of \$668,818.26.
