Piper Jaffray Report

Eric Anderson, Piper Jaffray, presented information on proposed borrowing(s) for Capital Projects. The Park District holds a Aaa rating. Debt would be structured to preserve and protect, both now, and in the future the District's rating. To allow for future Capital Project investment, debt would be structured to fund three near term major projects and fund "mini major" projects in the next 10 years. The proposed schedule may be adjusted slightly if desired, however any bond levies affecting levy year 2018 must be filed by February 27, 2019. Commissioners engaged in a question and answer session. Chair Slepicka thanked Mr. Anderson for his presentation and attending the meeting.
