<u>CONDUCT OF PUBLIC HEARING concerning the intent of the Board of Park Commissioners to sell General Obligation</u> Limited Park Bonds

President Randel opened the Bond Issuance Notification Hearing to receive any comments relative to the District's proposal to sell not to exceed \$20,000,000 in General Obligation Limited Park Bonds. These proposed bonds are to be issued for the payment of land condemned or purchased for parks, for the building, maintaining, improving and protecting of the same and the existing land and facilities of the District and for the payment of the expenses incident thereto. President Randel asked if any Commissioner would like to make a comment regarding the proposal to issue General Obligation Limited Park Bonds. No Commissioner chose to comment. President Randel opened the hearing to residents or members of the public to provide written or oral testimony. No one chose to comment. With all persons desiring to be heard been given an opportunity to present oral and written testimony regarding the proposal to issue the Bonds, President Randel requested a motion to adjourn the hearing. Commissioner Simon made a motion to close the public Bond Issuance Notification Hearing. The motion was seconded and unanimously approved on a roll call vote.
