#### **Staff Recommendation:**

Staff recommends the approval of the professional services contract amendment for architectural services with Wight & Company Inc., Darien, Illinois for architectural services of \$25,000 for assisting to prepare Illinois Clean Energy Community Foundation Net Zero Building Program grant application and \$75,000 for additional design services necessary to meet the grant specifications.

#### **Background & Analysis:**

The District has been exploring the possibilities of designing the new Activity Center with a desire to meet a Net Zero energy consumption. The projected cost of such a design and implementation ranged from \$1.3 to \$1.65 million dollars above our budget.

Recently, the Illinois Clean Energy Community Foundation has enlarged their grant offering up to \$2.0 million dollars which will cover the increased construction costs if we were to pursue a Net Zero building design.

#### **Staff Recommendation:**

Staff recommends the approval of the professional services contract with RATIO Architects Inc., Chicago, Illinois for Architectural and Interior Design Professional Services at a fee of \$140,000.

#### **Background & Analysis:**

In 2010, Meadowhill Park went through a park master plan process that was driven by the results of the Community Needs Assessment and public input meetings. This project was followed up with a 2016 review of the park amenities and programs that led to a revised Meadowhill Park Master Plan.

In 2017, the board allocated 2.5 million dollars to the planning and eventual renovation of Meadowhill Park and RATIO Architects Inc., was the firm selected to work on the design of the Meadowhill Park Master Plan. Because of RATIO's deep knowledge of the site and programming we believe their team is a natural choice to use for the Architectural and Interior Design Professional Services for the renovation/replacement of the Chalet.

The Chalet renovation/replacement was determined to be the second phase of the Master Plan implementation. The Chalet is a key area as a summer camp location along with other programing opportunities such as the Teams Challenge Course, Velodrome cycling, opportunities for parties and other rentals.

It is the opinion of staff that this firm would best represent the Districts interest in the Chalet renovation/replacement project.

#### **Staff Recommendation:**

Staff recommends the approval of the Driving Range Net Replacement and Repair base bid from West Coast Netting, Inc. of 5075 Flightline Dr. Kingman, AZ in the amount of \$43,000 for the replacement and repair of the driving range netting.

### **Background & Analysis:**

In 2017, staff was prepared to replace all the driving range netting at Sportsman's Country Club. It was determined at that time that we would stay with the old netting and make repairs as necessary with the anticipated closing of the range in early summer of 2019 for the start of the course renovation project. The heavy wet snow from the snow storm of November 25-26 did significant damage to fifteen (15) net panels and smaller rips in several other panels leaving the range in a condition that it could not open this spring with the nets in their current condition. Staff has filed a claim with PDRMA and we are waiting for the claims adjuster to provide us with a settlement number.
