NOTICE OF PUBLIC HEARING CONCERNING THE INTENT OF THE BOARD OF PARK COMMISSIONERS OF THE NORTHBROOK PARK DISTRICT, COOK COUNTY, ILLINOIS TO SELL NOT TO EXCEED \$16,000,000 GENERAL OBLIGATION LIMITED TAX PARK BONDS

PUBLIC NOTICE IS HEREBY GIVEN that on the 5th day of March, 2019, at 7:30 o'clock A.M., the Board of Park Commissioners of the Northbrook Park District, Cook County, Illinois (the "District"), will conduct a public hearing to be held in the Conference Room at the Joe Doud Administration Building, 545 Academy Drive, Northbrook, Illinois. The purpose of the hearing will be to receive public comments on the proposal to sell bonds, namely General Obligation Limited Tax Park Bonds in an amount not to exceed \$16,000,000 (the "Bonds"), for the purpose of building and equipping a new, approximately 44,000 square-foot activity center to be located at 180 Anets Drive, Northbrook, Illinois 60062 (the "Project"). The Project will be owned and operated by the District. A portion of the proceeds of the Bonds will be used to pay certain expenses incurred in connection with the issuance of the Bonds.

The above-noticed public hearing is required by Section 147(f) of the Internal Revenue Code of 1986, as amended. At the time and place set for the public hearing, residents, taxpayers and other interested persons will be given the opportunity to express their views on the Project, the proposed plan of financing and the issuance of the Bonds. Written comments may also be submitted to the District at 545 Academy Drive, Northbrook, Illinois 60062, Attention: Molly Hamer, Executive Director, on or before the 5th day of March, 2019.
