Eric Anderson of Piper Jaffray congratulated the District on achieving the distinction of Moody's Aaa Bond Rating. Mr. Anderson reviewed the sale of General Obligation Limited Tax Park Bonds, Series 2019. The proceeds of the Bonds will be used to build and equip a new, approximately 44,000 square-foot activity center at Techny Prairie Park and Fields, providing for fitness and wellness activities, including an indoor walk track.
