MINUTES of the Board Meeting of the Northbrook Park District Board of Commissioners held Wednesday, December 12, 2018 in the Administration Building located at 545 Academy Drive, Northbrook, Illinois.

## CALL TO ORDER AND ROLL CALL

President Randel called the Board Meeting to order at 7:37pm. On a roll call by Assistant Secretary Peterson, the following members were in attendance:

#### APPROVAL OF AGENDA

President Randel called for any changes to the Agenda. Hearing none, Commissioner Simon made a motion to approve the Agenda. The motion was seconded and unanimously approved on a voice vote.

## **EXECUTIVE DIRECTOR REPORT:**

- 1) Parks and Properties staff continue to clean-up after the snow storm of November 25-26. Numerous trees sustained damage from the heavy snow. Meadowhill Aquatic Center saw the most significant tree loss where five 30-foot spruce trees were uprooted. The north-side driving range netting was heavily damaged and fifteen sections will need to be repaired. In our continued spirit of cooperation, after the Park District removed the most significant tree damage in our parks, we provided our wood chipper to Northbrook Public Works Department to give the Village the opportunity to expedite their clean-up as well.
- 2) Staff are planning for holiday week camps at the Sports Center, Greenbriar Gym and Leisure Center for 125-150 children. Additional programming such as Open Skate, Open Gyms and Sticks and Pucks will also be offered.
- 3) Breakfast and Lunch with Santa at Sportsman's Country Club were both sold out and fun was had by all! Executive Director Hamer commended Recreation Supervisor Eschker on the successful event.
- 4) Congratulations to NTCC on the recent production of *Mary Poppins, Jr.* NTYA will present *Pinkalicious* January 19-February 23 every Saturday at 10am and 1 pm.
- 5) New Recreation Supervisor Cameron Edelman started on December 12. He comes to us with a degree from Illinois State University and 5 years of experience at JCC of Chicago.
- 6) The Park District was featured in December's *Chicago Magazine* highlighting the best sledding hills in the Chicago area, Techny Prairie Park and Fields, and Sports Center was featured for our Speed Skating program.
- 7) Congratulations to Supervisor Wenzel on being named by *Golf Digest* as one of the Top Young Teachers in America for 2018-2019.
