MINUTES of the Board Meeting of the Northbrook Park District Board of Commissioners held Wednesday, September 18, 2019 in the Administration Building located at 545 Academy Drive, Northbrook, Illinois.

CALL TO ORDER AND ROLL CALL

President Randel called the Board Meeting to order at 7pm. On a roll call by Assistant Secretary Peterson, the following members were in attendance:

EXECUTIVE DIRECTOR REPORT:

- 1) The Chicago Fire hosted a free clinic for our house league soccer players on Friday, September 13. 130 players participated. We are continuing to try new ways of enhancing the house league experience.
- 2) Touch-A-Truck was held on Saturday, September 14 at Underwriters Laboratories. It was a beautiful day with great turnout. UL has been an excellent partner for the event.
- 3) The Father-Son Sports Night will be held on September 21. The event has been moved to the Greenbriar Gym.
- 4) The District is currently hiring two Recreation Supervisors. One in Athletics and Aquatics and the other in Figure Skating.
- 5) The Plein Air Painting Festival will be held September 28 and 29. Saturday afternoon and all-day Sunday at Village Green Park will feature an exhibition of artists' paintings from the event, live music and Plein Air painting demonstrations.
- 6) Director Loftus, Recreation Division Manager Shields and Sports Center Manger Taylor met with the new president of NBHL, Brad Walker, to discuss ice time and ways to make our partnership stronger.
- 7) Activity Center Update:
 - a. ComEd is in the process of rerouting the electrical service underground.
 - b. Storm sewer pipe installation continues with the main trunk line completed and the contractor is now installing the pipes for the parking lot.
 - c. September 18 was the first day for the concrete contractor to begin pouring the building foundation.
- 8) On September 18, in collaboration with the Northbrook Garden Club and resident Ed (Bud) Smith the District participated in a peony dig.
- 9) Marketing & Communications Director Scovic started with the District on September 3 and has been busy completing orientations with staff members.
- 10) M+C staff provided event support at Friday Night Flights (information table), Touch-A-Truck (photos, Shermerfest (information table and photos) and the Peony Dig project (photos).
- 11) Executive Director Hamer and Director Scovic met with Matt Petersen to discuss the District's sponsorship proposals.
- 12) Manager Stuart has started the compilation of the programs and information for the Winter Activity Guide which will be delivered to the Post Office on November 15.

- 13) Director Scovic attended Leadership Northbrook on September 13 and the Chamber's Women in Business Luncheon on September 17.
- 14) Food and Beverage vendor interviews were held, and the committee had a unanimous decision on their choice. Contract negotiations are in process.
- 15) On September 21, Sportsman's Country Club will be hosting the Northbrook Bluehawks Hockey Association Annual Fundraiser Golf Outing.
- 16) Executive Director Hamer, Director Loftus and Director Scovic attended the Maple School Ribbon Cutting Ceremony on September 3.
- 17) Executive Director Hamer attended Representative Brad Schneider's Neighborhood Open House at the Northbrook Public Library on September 5.
- 18) On September 18, Executive Director Hamer and Director Munn attended the Special District Summit in Chicago. The Summit was sponsored by Governing Magazine and AT&T and provided information on leveraging technology as a Special District.
- 19) NSSRA now owns the building located in Highland Park. Clean-up Day will be held with most agencies sending two staff members to assist.
- 20) On Friday, September 20 the second edition of the Board Bulletin packet will be delivered. The packet will contain information on topics that are important but that do not require Board action.
