Consider Activity Center Commissioning Proposal

Lois Vitt Sale of Wight & Company presented information on professional services for building systems commissioning at the new Activity Center. With the acceptance of the Illinois Clean Energy Community Foundation grant the requirements for proof of Net Zero energy is an 18-month building system monitoring process. It is recommended to hire an outside company to do the commissioning due to time sensitive benchmarks. Commissioners engaged in a question and answer session. Hearing none, the Committee moved to approve the contract for professional services with Aero Building Solutions of Franklin Park, Illinois for building systems commissioning and monitoring services in the amount of \$116,540 to the full Board for approval.
