# **Eric Anderson, Piper Jaffray**

Eric Anderson of Piper Jaffray presented information on proposed borrowing(s) for Capital Projects. Commissioners engaged in a question and answer session. Eric will return on December 11 to present funding options that consider the upcoming capital expenditures needed at the Sports Center. ## Consider Ordinance 19-O-5, Tax Levy

Director Munn provided background information on the Tax Levy Ordinance 19-O-5. The legal notice for the Public Hearing to be held on Wednesday, December 11 at 7pm will be published in *The Northbrook Tower*. Chair Chalem called for questions. Hearing none, the Committee moved to approve Ordinance 19-O-5, providing for the 2019 Levy and Assessment of Taxes for the Northbrook Park District, Cook County, Illinois, to the full Board for adoption.

#### Consider Resolution 19-R-3, 2019 Reduction in Tax Levy

Director Munn provided background and analysis of the 2019 Tax Levy Reduction Resolution. The Resolution directs the Cook County Clerk to reduce a specific levy if the Tax Levy Ordinance exceeds the tax cap amount calculated by the Clerk. If a reduction is necessary the District would reduce the levy within the Corporate Fund. Chair Chalem called for questions. Hearing none, the Committee moved to approve Resolution 19-R-3, a Resolution providing for the possible reduction of the 2019 Levy and Assessment of Taxes for the Northbrook Park District, Cook County, Illinois to the full Board for adoption.
