APPROVAL OF MINUTES

The Parks and Properties Committee Meeting Minutes of October 15, 2019 were approved as presented.

INFORMATIONAL ITEMS/VERBAL UPDATES

Activity Center Change Orders

Director Dalton provided the monthly update of Change Orders necessary for the Activity Center. Commissioners engaged in a question and answer session. Commissioner Ziering asked that Director Dalton inform the Board when the pre-cast panels would be installed.

Elimination of Teams Course Programs and Facilities

Directors Dalton and Loftus provided background information on the Teams Course Program and facilities. The demolition of the Outdoor Education Center (OEC) and the climbing wall is planned in the 2020 Capital Improvement Plan. As a result, it is recommended that the Teams Course programming be eliminated. Commissioners engaged in a question and answer session.

UNFINISHED BUSINESS

Proposal from Lakeview Covenant Church

Executive Director Hamer and Director Dalton met with Pastor Joshua Kang of the Lakeview Covenant Church regarding a potential parking agreement. Staff recommends not pursing a parking agreement with the church and the use of their parking lot for activities associated with Oaklane Park.

NEW BUSINESS

Consider Northbrook Park District Mowing Contract – Southwest, Bid #2177

Director Dalton reviewed the Northbrook Park District Mowing Contract – Southwest, Bid #2177. Commissioners engaged in a question and answer session. Chair Chambers called for additional questions. Hearing none, the Committee moved to approve the Southwest Mowing Contract for \$138,768 from Brightview Landscapes, LLC of Long Grove, Illinois to the full Board for approval.

Consider Northbrook Park District Mowing Contract – Northeast, Bid #2178

Director Dalton reviewed the Northbrook Park District Mowing Contract – Northeast, Bid #2178. Chair Chambers called for questions. Hearing none, the Committee moved to approve the Northeast Mowing Contract for \$165,144 from Brightview Landscapes, LLC of Long Grove, Illinois to the full Board for approval.

COMMISSIONER UPDATE

Chair Chambers requested that Commissioner Curin be allowed time to address the Committee since he was not able to participate in the September Committee Meeting due to a weather-related issue. Commissioner Curin expressed his point of view on programming of ice time, the need to purchase ice time at other rinks and the feasibility of an additional sheet of ice at the Sports Center. Chair Chambers and Commissioner Curin will be meeting with staff on Friday, November 21 to review the Sports Center presentation that was previously provided. Prior to the Committee-of-the-Whole Meeting on Monday, December 2, staff will provide an analysis of a third sheet of ice as background information in preparation of the 2020 Capital Improvement Plan discussion. Commissioner Curin thanked the Commissioners for their time and consideration.
