VISITOR COMMENTS

Doug Gerleman, Northbrook resident, addressed the Board of Commissioners regarding sustainable landscaping methods. Mr. Gerleman updated his home landscape from turf to low maintenance plantings that require little water. VI. 12/11.86 Approval of Resolution 19-R-3, 2019 Reduction in Tax Levy

Motion: Commissioner Chalem moved to approve Resolution 19-R-3, a Resolution providing for the possible reduction of the 2019 Levy and Assessment of Taxes for the Northbrook Park District, Cook County, Illinois. Commissioner Curin seconded the motion.

Motion: Commissioner Chalem moved to approve Ordinance 19-O-4, an Ordinance Amending a Combined Annual Budget and Appropriation of Funds for the Northbrook Park District for the fiscal year beginning January 1, 2019 and ending December 31, 2019.
