Date: February 11, 2022

Staff Recommendation:

Staff recommends exiting the current 2018 lease extension of 98 Visage golf car GPS display units that will expire on December 31, 2022. A new rental agreement would go in effect for 48 months and the monthly payment will increase to \$4,704 from the current \$3,920 per month.

Background & Analysis:

We currently have 98 V2 units that communicate through Wi-Fi and 3G cellular service networks. Cell companies are in the process of sunsetting 3G cellular service used by our current units and we are faced with losing golf car tracking, fleet lockdown functionality, and critical pace of play management features at some point in 2022. With the new agreement we would be replacing the current V2 units with all new V3 Visage units. The V3 units operate over 4G and 5G cellular networks and provide improved graphics and additional features currently not available on the V2 unit.

Additional features include:

- 10" high-definition screen featuring the Shark Experience interface with Bluetooth pairing to integrated speakers, live sports ticker and weather.
- EZLocator integration. EZLocator is golf's premiere hole location software which uses 3D scanning technology to provide detailed slope analysis for accurate hole placement locations. After each possible pin location is determined by the software it will automate the pin placement process offering more and better pin placement configurations. Utilization will eliminate pin placement errors, allow for review of historical hole locations and adapt hole location availability for wet/dry weather and green speed variations.
- Action zones will be displayed on the screen when the car is within 30 yards of a restricted area.
- The customer survey module has four survey types.
- The maintenance tracking module offers gas vehicle diagnostics, automated alerts and per vehicle maintenance recommendations.
