MINUTES of the Parks and Properties Committee Meeting of the Northbrook Park District Board of Commissioners held, Tuesday, March 15, 2022 in person in the Joe Doud Administration Building at 545 Academy Drive, Northbrook, Illinois.

APPROVAL OF MINUTES

Commissioner Goodman moved to approve the Minutes of the Parks and Properties Committee Meeting of February 16, 2022. Commissioner Curin seconded the motion. Motion passed by voice vote.

INFORMATIONAL ITEMS/VERBAL UPDATES

Jake Vest, Trades Manager - Net Zero Presentation

Trades Manager Vest presented information on Techny Prairie Activity Center's Net Zero performance. The commissioning for TPAC began in December 2020. Trades Manager Vest provided information on the photovoltaic system that is being used at TPAC. The photovoltaic system performance period that was agreed upon between the District and the Illinois Clean Energy Community Foundation (ICECF) began in June 2021. The ICECF would allow the performance period to be pushed back if the District could prove Net Zero for twelve consecutive months prior to May 2022. Staff are able to monitor the photovoltaic system and troubleshoot any issues. TPAC staff were very helpful in identifying issues and alerting Trades staff. TPAC received the New Buildings Institute Net Zero verification on March 14, 2022 and the final grant payment from the Illinois Clean Energy Community Foundation will be awarded in the amount of \$666,613.04. Commissioner Curin thanked Trades Manager Vest for his presentation.

Synthetic Safety Surface

Director Leiner provided background information and analysis for the upcoming playground replacements outlined in the Capital Improvement Plan. Staff would like to explore which amenities are to be included in the playground replacement process. Director Leiner discussed the benefits of installation of a synthetic turf safety surface (playground grass) as opposed to engineered wood fiber (wood chips). He also presented a sample of synthetic safety surface for the Commissioners to use as a reference. The benefits of using synthetic safety surface include ease and efficiency of regular maintenance, consistent availability, uniform fall height and shock absorbency performance, improved drainage, increased playability and an antimicrobial surface. Drawbacks Director Leiner presented included, the high surface temperature and cost. At the July 15, 2019 Parks and Properties Committee Meeting, staff presented a detailed playground analysis which was used as a foundation for developing the playground replacement schedule outlined in the current CIP. Commissioners engaged in a question and answer session.

Director Leiner provided background information on HVAC Service for all Buildings – Renewal. Commissioner Curin moved to approve the renewal of the HVAC Services – All Buildings, Bid #2194 base bid and Alternate 1 for two years in the amount of \$26,892.00 from the Stone Group of Chicago, Illinois to the full Board for approval. Commissioner Goodman seconded the motion. Motion passed by voice vote.

Consider HVAC-R Services - Ice Refrigeration Equipment: Northbrook Sports Center, Bid #2195 - Renewal

Director Leiner provided background information on HVAC- R Service - Renewal. Commissioner Curin moved to approve the HVAC-R Services – Ice Refrigeration Equipment: Northbrook Sports Center, Bid #2195 in the amount of \$27,052.92 for Option Year Two with the ability to renew for one additional year from F.E. Moran, Inc. Mechanical Services of Northbrook, Illinois to the full Board for approval. Commissioner Goodman seconded the motion. Motion passed by voice vote.

Consider Cedar Lane Tot Lot Playground Replacement, Bid #2222

Director Leiner provided background information on the Cedar Lane Tot Lot Playground Replacement, Bid #2222. Commissioner Curin moved to approve the Cedar Lane Tot Lot Playground Replacement, Bid #2222 base bid and Alternate 1 Synthetic Turf Installation in the amount of \$161,786.50 from Hacienda Landscaping, Inc. of Minooka, Illinois to the full board for approval. Commissioner Goodman seconded the motion. Motion passed by voice vote.

Consider Meadowhill Park Playground Equipment, Bid #2223

Director Leiner provided background information on the Meadowhill Park Playground Equipment, Bid #2223. Commissioner Curin moved to approve the Meadowhill Park Playground Equipment, Bid #2223 base bid and Alternate #1 Synthetic Turf Installation in the amount of \$288,955.00 from Hacienda Landscaping, Inc. of Minooka, Illinois to the full board for approval. Commissioner Goodman seconded the motion. Motion passed by voice vote.

Consider Pool Apparatus Painting, Shell Painting & Caulking, Bid #2220

Commissioner Curin moved to table Pool Apparatus Painting, Shell Painting & Caulking, Bid #2220 to an Action Item on the March 30, 2022 Regular Board Meeting. Commissioner Goodman seconded the motion. Motion passed by voice vote.
