INFORMATIONAL ITEMS/VERBAL UPDATES

ComEd Energy Efficiency Grants

Director Leiner brought forward the opportunity to apply for the ComEd Energy Efficiency Grant. Staff announced that based on a partnership with Lead Electric of Barrington, Illinois the Park District has been awarded \$613,879.50 in grants from ComEd to install energy-efficient lighting throughout District facilities and parks. The fully funded grant program requires no match from the Park District and is designed for and directly marketed to units of local government to work toward the goal of reducing energy usage. Commissioners engaged in a question and answer session. Commissioner Ziering thanked Director Leiner for his work on this project.

Consider Landscape Maintenance Services, Bid #2226

bid rate of \$45.00 an hour for Landscape Maintenance Services, Bid #2226 from Milieu Design, LLC of Lake Zurich, Illinois, in the amount of \$191,895 to the full Board for approval. Commissioner Goodman seconded the motion.

Consider Countryside Park Playground Equipment Options

Director Leiner provided background information on the playground equipment options for Countryside Park. Two playground concepts were provided by Play Illinois LLC/Burke. Hearing none, Chair Chalem moved to approve the two Countryside Playground Play Equipment design concepts provided by Play Illinois LLC/Burke, to be made available to the public for voting. Commissioner Goodman seconded the motion.
