MINUTES of the Board Meeting of the Northbrook Park District Board of Commissioners held Wednesday, June 22, 2022 in the Joe Doud Administration Building located at 545 Academy Drive, Northbrook, Illinois.

EXECUTIVE DIRECTOR'S REPORT

On behalf of Executive Director Hamer, Director Loftus provided the following report.

- 1) The First Tuesday in the Park was held yesterday. Attendance was lower than normal but that was probably due to the extreme temperatures. Tuesdays in the Park continues until the end of July.
- 2) Athletics staff held a successful Pickleball tournament last weekend. Twelve teams competed for a monetary prize and pickle juice.
- 3) The pools passed the IDPH inspection last week and staff received a 4-Star audit from StarGuard Elite for the first of three unannounced visits this summer.
- 4) Camp is underway and going well. We are now in our second week of the traditional 8-week offerings.
- 5) The Adventure Campus Hiring promotion was released. Hopefully on your way into the meeting, you have passed a banner. Postcard will be delivered early next week. The Marketing & Communications Division kicked off this week with banners, yard signs, press release, new website page with additional information to be shared through social media and paid advertising. The response to parent communication sent last week has been understanding and appreciation of efforts have been shared.
- 6) Staff are preparing for the 4th of July activities. Parks will be supporting the Rotary Breakfast and Fireworks and assisting Recreation Division with the Liberty Loop and Northbrook Baseball's tournament. And a combined team with Marketing and Recreation are coordinating the parade staging. If you are interested in assisting with the race in the morning, please let me know after the meeting.
- 7) Brian Romes, Executive Director of the Highland Park Park District reached out this morning with a request to temporarily accommodate their residents as they have a pool repair. Highland Park will be letting their passholders know that they can swim at Sports Center pool tomorrow afternoon into Friday for free and resident rates will be charged for residents without passes. Attendance will be tracked and staff will work with Highland Park on payment of daily fees.
- 8) LED light retrofits have been completed at the Heritage Oaks Golf Maintenance Facility and work is ongoing at the Leisure Center.
- 9) The landscape maintenance contract has begun. Contractors have performed maintenance at the Northbrook Sports Center Pool, Meadowhill Aquatic Center and Village Green Park.

- 10) The completion of the playground replacement at Cedar Lane Tot Lot has been delayed due to material shortages resulting from a union strike against the Chicago Area Aggregate Producers Association. At this time no aggregate stone is being produced. Staff is hopeful the project will restart quickly once the strike is settled.
- 11) The Meadowhill Park playground replacement project has begun.
- 12) Poured in place playground safety surface repairs were completed at Village Green Park.
- 13) Core Mechanical has been retained to make repairs to the HVAC unit at Heritage Oaks Golf Club. Temporary cooling units are in place to maintain a comfortable temperature inside the facility. The lead time on repair parts is a minimum of 15 days. Staff expects repairs to be completed by early July.
- 14) Golf marketing with a more regional focus kicked off this month through magazine and radio outlets. The timing for this was specifically set for June to be sure the course would be in a good state for increased use.
- 15) The M&C team continues to capture photographs of summer events including camps, parks, concerts and attended the first Tuesdays in the Park concert to promote District programs and events and build the email distribution list.
- 16) Live music at the Acorn Grill + Terrace will be held on Friday, June 24 at 6pm featuring Steven Zane.
- 17) Executive Director Hamer and Director Loftus attended Dr. Larry Hewitt's retirement celebration.
- 18) On June 10, Executive Hamer attended the Chamber Golf Outing held at Heritage Oaks Golf Club. Thank you to Commissioners Goodman, Schyman and Simon for attending the event.
- 19) On June 13, Executive Director attended the IAPD Golf Outing held at Heritage Oaks Golf Club. Thank you to President Chalem and Commissioners Chambers, Simon and Ziering for attending the event.
