MINUTES of the Board Meeting of the Northbrook Park District Board of Commissioners held Wednesday, September 28, 2022 in the Joe Doud Administration Building located at 545 Academy Drive, Northbrook, Illinois.

EXECUTIVE DIRECTOR'S REPORT

- 1) Friday Night Lights Soccer was held last Friday at Techny Prairie Park and Fields. Another evening of soccer is scheduled for this Friday night and flag football's night is Friday, October 7. The program starts at 5:15pm each week.
- 2) Staff hosted the Park District of Oak Park for a tour at Techny Prairie Activity Center. Oak Park is building a Net Zero facility.
- 3) Touch-a-Truck was held at UL on Saturday, September 17. An estimated 1,500-2,000 people attended the event.
- 4) Senior Trips returned for the first time since the pandemic. Trips were to Denny Diamond and Cabaret this month. Staff and Seniors are looking forward to more trips.
- 5) Autumnfest will be held on Saturday, October 8 from 2-5pm at Meadowhill Park.
- 6) On Friday, October 21, the Halloween 3K and a first-ever pet parade will take place at Techny Prairie Park and Fields. The pet parade starts at 5pm with the race at 6pm.
- 7) The Grounds Department is once again dealing with full-time staffing challenges. The team is currently three full-time employees short. Staff is working to advertise positions and recruit new staff.
- 8) Meadowhill Park playground is now complete and open to the public. Join us for the official ribbon cutting on Wednesday, October 12 at 4:30pm.
- 9) The District will be submitting the Williamsburg Square Park OSLAD Grant application this Friday, September 30.
- 10) The Parks Division is in the process of winterizing the pool facilities. Staff also supported the setup and operation of Shermerfest.
- 11) The Marketing & Communications Division coordinated and created marketing materials for the Williamsburg Square Park Community Open House events. Staff collected all of the input.

- 12) The District hosted the NSSRA Swing Golf Outing on Friday, September 16 at Heritage Oaks Golf Club. Both courses were utilized to accommodate the 172 players. Thank you to Commissioners Simon and Ziering for playing and President Chalem for attending the lunch to welcome all of the players.
- 13) The Classic 18 hosted the Boy's IHSA Regional on September 28. The GBN Boys' team won the Regional event and will move on to Sectionals.
- 14) The Acorn Grill + Terrace had a good turnout for the fourth and final Live Music event of the year. With the dip in temperatures, the performance was set up inside instead of on the Terrace.
- 15) The Ladies Club Championship was held on Saturday, September 17 and was won by longtime league member Carol Golucki. The Men's Championship was won by life-long Northbrook resident Ryan Fallows.
- 16) The Finance Division is working with staff to prepare budget drafts.
- 17) The Technology Department successfully added additional storage backup in the cloud and have rolled out Security Awareness and Phishing Alert Button trainings.
- 18) The Senior Leadership Team attended a two day retreat to work on the 2023 Capital Improvement Plan.
- 19) Executive Director Hamer attended the Chamber Board meeting on September 8.
- 20) On September 15, Executive Director Hamer and several staff members attended the WILS Luncheon. Director Scovic was installed as the 2022-2023 President.
- 21) Executive Director Hamer attended the Chamber Business After Hours event held at Heritage Oaks Golf Club in the Brook Room on September 15. Thank you to Director Scovic and Executive Administrative Assistant Peterson for coordinating the event and to Open Kitchens for co-hosting and providing two drink tickets to attendees.
