Staff Recommendation:

Staff recommends the approval of the Irrigation Pump and Controls Replacement, Bid #2236 for the Total Base Bid and Alternate #3 for the replacement of the Heritage Oaks Classic 18 Irrigation Pump and Controller, Anetsberger Golf Course and Techny Prairie Park and Fields Irrigation Pump and Controller, Heritage Oaks Legacy 9 Irrigation Pump Controller only, and the connection of the Heritage Oaks Golf Club Well Pump station to the Classic 18 Controller, in the amount of \$643,011.00 from Liebold Irrigation, Inc. of East Dubuque, Illinois.

Background & Analysis:

As previously discussed, the irrigation pumps and controllers that service the Heritage Oaks Classic 18 and the Anetsberger Golf Course and Techny Prairie Park and Fields are at the end of their useful life and require replacement. In addition, the irrigation pump controller that services the Heritage Oaks Legacy 9 is nearing the end of its useful life and replacement is being recommended to capture economy of scale.

The District received one bid for this project.

Staff Recommendation:

Staff recommends the approval of the three-year hourly rate schedule for Tree Maintenance Services, Bid #2231, from Nels Johnson SavATree of Evanston, Illinois. Staff further recommends allocating \$65,000 for tree maintenance performed by Nels Johnson SavATree through the remainder of 2022.

Background & Analysis:

Before this bid cycle, the District previously maintained two separate tree maintenance agreements. One agreement at Heritage Oaks Golf Club and another shared service agreement with the Village of Northbrook for tree pruning throughout the park system.

The Heritage Oaks Golf Club Tree Pruning, Bid #2216 was awarded to Nels Johnson SavATree and the award amount was below the threshold requiring Board approval. The shared service agreement between the Park District and the Village of Northbrook was awarded to Advantage Tree Care. The scope of work specified in the Nels Johnson SavATree agreement and the Advantage Tree Care agreements has been completed for 2022. Staff is not recommending renewing either agreement in its existing form.

The specifications for the two agreements were structured differently. The Heritage Oaks Golf Club Tree Pruning bid requires tree climbers to complete most of the pruning work. The contract is a unit cost agreement per tree.

The park system bid specifications were structured by the Village of Northbrook for their operational needs, and the specifications are that of a parkway pruning bid. Based on these specifications, the shared contract with the Village was not as effective for a significant amount of the park system which cannot be maintained via a bucket truck like the Village's tree inventory.

Due to the concerns with specifications in the park and golf tree contracts, staff opted to develop an hourly rate climber specification due to the nature of the work requested. The previous park and golf specifications requested unit costs per removal and tree pruned. This does not take into account the unique nature of the park system. Costs for maintaining a tree are different based on location. For example, the effort necessary to remove a tree from the top of the Wood Oaks sled hill is different from the parking lot adjacent to the same park.

The hourly rate bid structure allows for the contractor to charge a variable fee based on the actual time it takes to complete a task versus developing an inflated unit cost to cover hard-to-reach trees. Furthermore, by specifying climbing, staff is actively minimizing the root compaction of the tree inventory by keeping bucket trucks out of the parks as much as possible.

In short, the District is moving away from two separate agreements to an improved single agreement in use for the entire Park District.

The Park District received one bid for the specified hourly rate contract with climbers.

The District has traditionally used contractors for larger-scale removals. At this time, the District has a backlog of large-diameter trees requiring removal that are beyond the Parks Division's ability to remove. This allocation will allow the District to move through the backlog of tree removal and pruning that has accumulated. The District currently has a backlog of approximately 75 trees of various sizes that are permitted and ready for removal.

Beyond that task, the additional funds would be used for as-needed smaller-scale removals and safety pruning. This contract would help offset the existing labor shortage as smaller removals and limited ground pruning have previously been completed in-house.

Staff expects to use the corresponding hourly rates to budget tree maintenance each fiscal year based on existing conditions that year.

The lowest qualified bidder Nels Johnson SavATree currently provides tree removal and pruning services at various locations throughout the District. The District has a long-term successful relationship with the contractor.

Staff Recommendation:

Staff recommends the approval of the Contract Landscape Maintenance Services, Bid #2234 for year one of the Base Bid in the amount of \$63,420.00 and the 2023 Fall Clean-up Alternate in the amount of \$6,225.00 for a total amount of \$69,645.00 from Milieu Design LLC of Lake Zurich, Illinois with the option to renew years two and three.

Background & Analysis:

This contract includes select landscape maintenance and fall clean-up at the following sites: Anetsberger Golf Course Clubhouse (Techny Prairie Center), Coast Guard Park, Joe Doud Administration Building, Leisure Center and Indian Ridge Park, Meadowhill Aquatic Center, Ed Rudolf Velodrome, Northbrook Sports Center and West Park, Techny Prairie Activity Center, Techny Prairie Park and Fields and Village Green Park.

While this is a three-year contract, staff is only recommending the approval of year one. Year one of this agreement will act as a bridge to support rebuilding the Grounds Department. Staff has set a goal to be fully staffed in the coming year. Currently, the Department has two of five full-time positions filled and four of thirteen permanent part-time positions filled. When fully staffed, 66% of staff will be new in their roles next season.

This contract will give the Department a foundation of support while new staff is familiarized with routines, park sites, safety procedures, equipment operation and regular job duties. In addition, the District will have a contractor already on board if staffing efforts are not as successful as desired.

The legal bid includes an hourly rate for on-demand, as-needed, non-prevailing wage landscape services. However, at this time, staff is not requesting approval for an hourly rate contract.

Background & Analysis:

The project will include professional services to ecologically maintain 48.56 acres of designated native open spaces within Coast Guard Park, Engelhardt Park, Floral Park, Heritage Oaks Golf Club, Techny Prairie Park and Fields and Wood Oaks Green Park.

Staff recommends proceeding with the base bid of \$250,411.00 for three years. The initial year of the contract is more expensive to aggressively treat and control invasive plant species, which will lead to more healthy native plant management through the three years of the contract. V3 Construction Group, Ltd. completed Phase I of the Wood Oaks Green Park Shoreline Restoration in 2021. V3 was also the Village of Northbrook contractor for the stormwater management projects completed at Wescott Park and West Park. Staff have been very satisfied with their workmanship and responsiveness. The DuPage County Forest Preserve also provided a positive reference.
