Date: January 13, 2022

Staff Recommendation:

Staff recommends approving the roof replacement for the Wood Oaks Green Park Tennis Building for \$22,073 and Heritage Oaks Classic 18 Pump House for \$9,208. In addition, staff recommends the approval of repairs to the Heritage Oaks Golf Maintenance Facility roof for \$18,056. The total recommended award is \$49,337 to Garland/DBS, Inc. of Cleveland, Ohio.

Background & Analysis:

OMNIA competitively bids for products and services on a national level and meets Illinois State Procurement requirements. The OMNIA contracts are competitively solicited and publicly awarded by a government entity. The roof replacement project at Wood Oaks Green Park and the Heritage Oaks Pump House will consist of removing and replacing the existing shingles, flashing and vents.

The repair of the Heritage Oaks Maintenance Facility roof will entail removing the shingles around the cupola, removing the cupola, and installing new shingles. In addition, the siding around the large skylights will be removed and replaced.

WHEREAS, the District has determined that the Property is beyond its useful service life; and

WHEREAS, Section 8-22 of the Illinois Park District Code provides as follows:

"Whenever a park district owns any personal property that in the opinion of three fifths of the members of the board then holding office is no longer necessary, useful to, or for the best interests of the park district, three-fifths of the park board then holding office, at any regular meeting or at any special meeting called for that purpose, by ordinance, may authorize the conveyance or sale of the personal property in any manner that they may designate, with or without advertising the sale"; and

WHEREAS, this ordinance is being considered at a regular meeting of the Board of Park Commissioners of the District.

NOW, THEREFORE, BE IT AND IT IS HEREBY ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE NORTHBROOK PARK DISTRICT AS FOLLOWS:
