INFORMATIONAL ITEMS/VERBAL UPDATES

Synthetic Turf Playground Safety Surface

Director Leiner reviewed the District playground replacement plan and parameters to install synthetic turf safety surface (turf) versus Engineered Wood Fiber (EWF) at playgrounds. The District's current approach has been to budget for and include turf in playground replacements at community parks, a park over 10 acres in size, with parking lots and dedicated Tot Lots. EWF is considered to be ADA accessible when properly maintained, including a yearly addition of new EWF and frequent raking. The District meets the standard of care necessary to maintain EWF that is safe and accessible. Commissioners engaged in a question and answer session.

Stonegate Park Playground Opening Update

The Stonegate Park Playground Grand Reopening will be held on Saturday, July 1 from 11am-12:30pm. The ribbon cutting ceremony will be held at 11:30am.

Neighbor Concern Heritage Oaks Golf Club Hole #15

Director Leiner provided an update regarding a neighbor concern at Heritage Oaks Golf Club on hole #15. The resident purchased their home in 2020 and shared concerns about golf balls on their property and water issues. Directors Leiner and Baron have met with the resident.
