EXECUTIVE DIRECTOR'S REPORT:

- 1) The Liberty Loop and Liberty Lap were held on Saturday, July 1 at Techny Prairie Park and Fields. Vice President Goodman and his family joined 350 registrants on the course. Thank you to President Chalem and Commissioners Chambers, Chao, Kumar and Schyman for attending and helping at the finish line.
- 2) The Stonegate Park Playground Grand Re-Opening and Ribbon Cutting took place on Saturday, July 1. Despite the iffy weather the turnout was wonderful. Thank you to Directors Leiner, Loftus and Scovic and Recreation Supervisor Mucci for organizing the event. Thank you to President Chalem, Vice President Goodman and Commissioners Chambers, Chao, Kumar, Schyman and Silverman for attending.
- 3) The 4th of July parade was successful with 43 parade participants. Thank you to President Chalem and Commissioners Chambers, Chao, Kumar and Silverman for driving golf cars.
- 4) On August 7, the Theatre Arts Workshop Camp performed Cats: Young Actors Edition.
- 5) Unplug Illinois Day was held on Saturday, July 15. The campaign created by IPRA encourages people to unplug from their electronic devices and plug into play, creativity, friendship, adventure and family. Senator Laura Fine sponsored Senate Resolution 319 declaring July 15 Unplug Illinois Day. On Wednesday, July 12, Director Scovic coordinated a promotional filming at Techny Prairie Activity Center with Senator Fine, Barbara Arango from IPRA and Executive Director Hamer.
- 6) The Cardboard Regatta was held at Northbrook Sports Center Pool on Saturday, July 22. Fifteen boats took to the water.

- 9) The Kids' Duathlon will be held at the Meadowhill Park Velodrome on July 28 from 6-9pm.
- 10) National Night Out will be held at Meadowhill Aquatic Center on Tuesday, August 1 from 6-9pm. The Park District hosts the event for the Northbrook Police Department.
- 11) The Performancing Arts Department received an Illinois Arts Council grant in the amount of \$9,600 for general operating support. Congratulations to Superintendent of Arts & Recreation Sweet and Performing Arts Supervisor Kambach on the successful grant application.
- 12) On July 3, the District welcomed Nieta Gates as the new Human Resources Manager.
- 13) The teen organized Glow Run raised \$17,000 in support of mental health and honoring Dylan Buckner. The event was held at Techny Prairie Park and Fields on July 7 at 7pm. Thank you to Superintendent of Athletics & Facilities Shields, Athletic Manager Shea and Intern Taffel for helping to coordinate the event logistics.
- 14) Party on the Green will be held Saturday, August 12 at Village Green Park from 4-9pm. The movie *The Mitchells vs. the Machines* will be shown at dusk.
- 15) Director Loftus provided an update on Adventure Campus. For the 2023-2024 school year, 37 staff will be returning and waitlists have been cleared except at Hickory Point Elementary School. To date 33 students remain on the waitlist.
