MINUTES of the Board Meeting of the Northbrook Park District Board of Commissioners held on Wednesday, December 13, 2023 in the Joe Doud Administration Building, 545 Academy Drive, Northbrook, Illinois.

CONDUCT OF PUBLIC HEARING CONCERNING 2023 TRUTH-IN-TAXATION

President Chalem opened the Public Hearing on the 2023 proposed Tax Levy increase for the Northbrook Park District. With all persons desiring to be heard and having been given an opportunity to present oral and written testimony regarding the 2023 proposed Tax Levy, President Chalem requested a motion to adjourn the Hearing. Commissioner Chambers made a motion to close the 2023 Truth-in-Taxation Public Hearing. Commissioner Silverman seconded the motion.

ERIC ANDERSON, PIPER SANDLER

Eric Anderson will be retiring from Piper Sandler at the end of 2023. Mr. Anderson began his partnership with the District in 2004. Mr. Anderson successfully presented the District to Moody's and earned the first park district Aaa rating in the nation. As a team, Mr. Anderson and the District had multiple successful projects including the Moving Forward 2017 Comprehensive Master Plan. He thanked the Board for welcoming him as a valued partner and being an engaged board. Mr. Anderson noted that it has been a pleasure and privilege to represent the Park District. He attended 62 meetings in his tenure. On behalf of the Board of Commissioners, President Chalem thanked Mr. Anderson for his years of service and for helping the District accomplish goals, and wished him the very best in retirement.

Green Acres

Executive Director Leiner provided an update on the status of the Green Acres property. Northbrook Village Manager Pavlicek informed him that the Village Trustees unanimously approved a Resolution approving a pre-development agreement with GA Northbrook LLC (Green Acres Redevelopment) for a public-private partnership to support the redevelopment of the Green Acres Country Club property on Dundee Road. The property development will include a data center, a Village municipal campus and open space in partnership with the Forest Preserves of Cook County. The Park District will not receive any property for a park. A TIF application will be submitted. Commissioners engaged in discussion.
